Summary of Duties:

Under the direct supervision of the behavioral health director, the psychiatrist is responsible for providing medical and psychosocial evaluation, developing and implementing treatment plans, including prescription of psychotropic medications, monitoring and evaluating treatment results of assigned client.

Essential Duties:

- Evaluates clients by interviewing client, family, and other persons, conducting physical
 examinations, observing behaviors, reviewing medical history and related documents; selecting,
 administering, and interpreting psychological tests; ordering laboratory tests and evaluating
 results.
- Develops treatment plans by determining nature and extent of cognitive, emotional, developmental, social, and behavioral disorders; establishing treatment goals and methodologies.
- Treats patients by utilizing psychotherapeutic methods and medications; discussing progress towards goals with clients; providing instructions; monitoring effect of medications.
- Maintain interdisciplinary treatment by reviewing treatment plans and progress; consulting and collaborating with primary care physicians, mental health therapists, nurses, and other health care providers.
- Complies with agency productivity standards and maintains an appropriate caseload to reach the weekly expectation of client contact and budgeted hours.
- Continually assess the needs and symptoms of clients and families formulating psychosocial diagnosis, gathering history, and determining the most appropriate method(s) of providing treatment/evidence based practice.
- Maintain a client file to level of requirements mandated in agency policy and completes documentation in a timely manner.



Qualifications:

- Required CA Medical License in Good standing, CA DEA, Board Certified. Must maintain licensure
 as a condition of employment.
- Experience working with dual diagnosed/co-occurring patients with both a substance use disorder and a mental illness.
- Knowledge of principles and techniques of social, cultural, and intergenerational dynamics of Asian immigrants and refugees.
- Excellent interpersonal, communication and organizational skills.
- Available to work flexible hours, including evenings and weekends as needed.
- Possession of a valid California driver's license and insurable driving record.
- Successfully meet the post-offer/pre-hire physical and DMV Driving Record Search requirements and receive an eligibility status for Level II Background Check required by the State of California.
